The selected candidate shall have no right/claim for regular appointment at this Institute, as the engagement is co-terminus with the Project/Scheme. Interested candidates may attend Walk-in-Interview on the dates as indicated alongwith original certificates and typed bio-data with one set of attested copies of each their certificates with passport size photograph. No TA/DA will be paid for attending the interview.

All eligible candidates are advised to be present at least 60 minutes before scheduled time on the date of interview for completing necessary formalities. Canvassing in any form will disqualify the candidates.

#### Age limit - 22- 35 Years

Emoluments: Rs 30000/- per month.

**TA &DA-** TA & DA will be provided permisiable to 7<sup>th</sup> Pay Commission Pay Matrix Level 6 of Government of Uttarakhand TA & DA rules for the visits which are officially approved by CEO, ULDB, which may be upgraded, if the CEO, ULDB feels is required for the job.

**Accomodation**– Room will be provided as per availabilit. If accomdation not provided then House allowance will be provided which is permisiable to 7<sup>th</sup> Pay Commission Pay Matrix Level 6 of Government of Uttarakhand HRA rules.

**Discipline**: Is required to show satisfactory performance of duties and maintain discipline as per the code of conduct and prevailing rules of the ULDB.

**Leave**: Not entitled for any regular leave. He/she will be allowed to avail Casual Leave (CL) and Restricted Holidays as per rules of the Govt. of Uttarakhand and as issued from time to time, after due approval from the project coordinator. CEO ULDB may grant permission for any additional leave, subject to a maximum of 20 days in a year, upon his discretion or as per the law of the land permits.

Income Tax: The concerned authority would be responsible for deduction of tax at source as applicable.

#### **Other Conditions**

- (i) Selected candidate will have to execute bond with ULDB on Rs 100.00 Non Judicial Stamp paper for the period of One Year which is likely to be extended based on reviewing and necessity of the the work.
- (ii) The sales executive will be under the administrative control of the concerned project coordinator of the project as per the directions from the CEO ULDB.
- (iii) The engagement will stand terminated on completion of the tenure of the scheme or on the date stated in the sanction order of the scheme whichever is earlier whether so communicated formally on individual basis or not.
- (iv) If sales executive leaves his/her assignment without permission for one month, he/she will stand terminated from the date of his/her absence.
- (v) Since sales executive is engaged for the scheme work full time, he/she will not be allowed to do any other work or to accept or hold another appointment with or without remuneration elsewhere.
- (vi) ULDB will have all the rights (intellectual property /proprietary) on outputs of the sales executive, made during the period of working in the ULDB.
- (vii) The sales executive shall have no legal right to claim his/her regularization/ appointment by absorption or otherwise against any regular posts or any further contractual engagement on termination of the scheme/project. The engagement in the scheme is purely time-bound, non-regular and on coterminus basis with the scheme. The services of the incumbent shall stand terminated automatically on expiry of the period given in the sanction.
- (viii) The sales executive may be deputed by the project coordinator of the project with prior approval of CEO ULDB to attend symposia/seminars/ conferences/workshop/fairs/exhibitions etc., in India.
- (ix) The sales executive is a full time worker and is required to adhere to the administrative, financial and disciplinary regulations of ULDB where the incumbent is working. Regular attendance of the sales executive will be ensured by the concerned project coordinator by keeping an attendance register.
- (x) The sales executive shall settle his/her claims within one year and in no case after the final settlement of the accounts of the scheme.
