2. Bid:

- B] The bid shall be submitted along with Cost of Bid Document (Bankers Cheque/ DD), Bid Security of ₹60,000/- (₹ Sixty Thousand Only) and Declaration as per Annexure I. Bankers Cheque/ DD/ FDR should be in favor of "Uttarakhand Livestock Development Board" payable at "Dehradun". Bid security if submitted in the form of FDR then the FDR must be valid up to 30 days after the date of validity of bid.
- C] The contract shall be for the full quantity as described in the above table or for district wise basis depending on connectivity available with the Service Provider.
- D] Correction, if any, shall be made by crossing out, initialing, dating and rewriting.
- E] All duties, taxes and other levies payable by the Service Providers under the contract shall be included in the total price.
- F] The rates quoted by the Service Providers shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- G] The price shall be quoted in Indian rupees only.

**4.** Technical Bid: Must be as per Annexure II having all the documentary proof as mentioned in Eligibility Criteria.

# 5. Financial Bid: BOQ (Financial Bid): must be submitted online in https://uktenders.gov.in.

Financial Bid should contain: Bill of Quantity (BOQ) QUOTE IN: Bidders Name and "Unit Rate & GST" Financial bids of Technically Qualified Bidders will only be opened. The decision of the committee on technical suitability shall be final and shall not be open for discussion. Date and time of opening of Financial Bid will be communicated through https://uktenders.gov.in.

# 6. Preparation, Sealing and Marking of Bid:

The Bidders shall submit cost of bid, bid security, declaration in ₹100.00 non judicial stamp paper and all documents as desired in the bid in sealed envelope duly marking the envelope by "Invitation For Bids for Internet and Voice Calling Facility" and a statement: "DO NOT OPEN BEFORE .......".

7. Each bidder shall submit only one bid.

# 8. Validity of Bid:

Bid shall remain valid for a period not less than 45 days after the dead line date specified for submission.

# 9. Evaluation of Bids:

# 9.1 Technical Bid:

Technical Bid shall be evaluated by the Committee on the basis of documents submitted in Technical Bids and other requirements establishing bidders eligibility & qualification. The list of Technically Qualified Bidders and date of opening of financial bids of technically qualified bidders will be intimated on https://uktenders.gov.in. The decision of the committee on technical suitability of bids shall be final and shall not be open for discussion.

### 9.2 Financial Bid:

- All the taxes and other levies indicated in the Financial Bid will be taken for the Financial Bid evaluation.
- Bid should be evaluated on all items together basis.
- The Bidder quoting the lowest price (L1) including all incidentals, taxes etc. will be selected for the award of contract

# **10.** Award of Contract

The ULDB will award the contract to the bidder whose bid has been determined to be substantially responsive and who has offered the lowest evaluated bid price. The successful bidder will have to sign agreement on non judicial stamp paper of ₹100.00 (the cost shall be borne by the successful bidder) & shall have to submit performance security @5.00% of Total Contract Value. Performance security shall be submitted in the form of Bankers Cheque/ DD/ FDR/ Bank Guarantee of any nationalized/ scheduled/ registered bank favoring/ pledged to "Uttarakhand Livestock Development Board" payable at "Dehradun". Performance Security if submitted in the form of FDR/ Bank Guarantee then the FDR/ Bank Guarantee must be valid up to 60 days of completion of performance obligations including warranty obligations.

A] The ULDB will notify the bidder whose bid is accepted for the award of contract. The terms of the accepted offer shall be incorporated in the purchase order.

#### **11. Other Terms and Conditions:**

- **Equipment:** SIM card wherever required if any, will be provided by the successful bidder. No additional cost may be given to the vendor.
- The rental of the voice and network connectivity is fixed and no extra bill should be allowed for GPRS/ GPS /VOLTE service as per financial bid.
- Monthly 30 GB of data service/GPRS should be provisioned. Post 30 GB the GPRS should be unlimited at throttled speed without any extra charges. 100 free local/STD SMS per day shall be provided on all connections with unlimited local and STD calling with free national roaming.

- The successful bidder must provide full time Service Manger who:-
  - (a). Should be responsible for all the relevant issues like billing issues, payments, issuing of new SIM cards in case previous SIM card damaged or lost, mobile number/SIM card swapping, suspension or restoration, no network or signal related issues.
  - (b). Must be available via email/telephones/SMS. There must be specific individual to serve as backup during vacations and other times if the named service manager is not available. Further the alternate manager must be able to be reached for emergency purpose during off hours.
- Bidder telecom service provider should provide satisfactory services which includes 24\*7 services, complaint resolution, issuing and activation of SIM within 24 hours with internet connectivity, when asked should provide free call details with bill to ULDB. No extra charges towards SIM activation or CLIP services would be payable under any circumstances.
- After deactivation of any SIM/ connections, there shall be zero billing for the deactivated period till further connection and SIM will be issued .
- The service provider will provide and maintain spare SIM cards in stock to meet requirements raised in exigency like lost/ damaged SIM cards already in use by users or in case of additional users.
- In case of not providing satisfactory services by Bidder telecom service provider than ULDB has the right to

a. cancel the tender document confiscating the performance security amount.

b. to stop the payment of the bills to the telecom service provider.

c. in case network is found down for more than 01 hour any day(s) or then rent for equal numbers of day(s) would be deducted from the bill or that particular month along with damages @5% per day of the bill amount subject to maximum of 10% in any month.

# **12. Liquidated Damage for Delays:**

Non satisfactory fulfillment of performance obligation will result in termination of contract & in such cases the Performance Security submitted by the successful bidder shall be forfeited.

#### **13. Resolution of Disputes:**

In case of dispute relating to the enforcement of the provisions of agreement, Chairman, ULDB or his authorized representative shall act as arbitrator in the matter as per the provisions of the Arbitration Act of Government of India.

Any dispute arising out of this agreement will be settled under the jurisdiction of Dehradun Court (under Uttarakhand high court).

14. Notwithstanding the above, the purchaser reserves the right to accept or reject any bid and to cancel the bidding process and reject all bids at any time prior to the award of contract.

- 15. Service Provider must submit a self declaration on affidavit regarding coverage/signal strength accordingly.
