All information pertaining to the subject of DSC is available on https://uktenders.gov.in All information with respect to this tender, like, any changes or any corrections or cancellation of the tender process, etc. are visible realtime on http://uktenders.gov.in all the time. 1. You are requested to submit your most competitive bid for hiring of services of 85 data entry operators (numbers may increase or decrease) under the centrally sponsored National Digital Livestock Mission (NDLM) to be implemented in for the four districts of Haridwar, Dehradun, Udham Singh Nagar and Champawat.

- 2. Under the NDLM Scheme, the rates for making available a total of 85 data entry operators (numbers may increase or decrease) for the districts of Dehradun, Haridwar, Udham Singh Nagar and Champawat may be quoted online on the Government of Uttarakhand's e-procurement websitehttps://uktenders.gov.in under the Bill of Quantities (BOQ) online.
- 3. The bid must be accompanied with a bid security of Rs. 275400.00 (Rupees Two Lakh Seventy Five Thousand Four Hundred) as Bid Security in the form of a Bank Guarantee or a fixed deposit receipt or demand draft or a pay order issued by a nationalized bank/scheduled bank/cooperative bank and pledged in favour of Uttarakhand Livestock Development Board (ULDB). The bid security must be valid for a period of 60 days after the expiry of the period of validity of the bid. Any bid submitted on https://uktenders.gov.in without the requisute bid security, undertaking and proof of purchase of bidding document offline will not be considered.
- 4. The rates quoted by the bidder will be applicable during the entire period of the contract and no change will be made in the rates during this period.
- 5. The rates quoted in the bill of quantities (BOQ) will be in Indian rupees.
- 6. The bidder shall submit the following documents offline to the Office of the CEO, Uttarakhand Livestock Development Board (ULDB), Pashudhan Bhawan, First Floor, Mothrowala, Dehradun-248001 before the last date and time of submission either by registered post or courier or in person:
- a. Cost of the tender document
- b. Bid Security
- c. Notarized declaration (as indicated in Annexure-II of the bidding document) on a non judicial stamp paper of Rs. 100.00 denomination.
- 7. Other terms and conditions are as per Annexure-1
- 8. Evaluations of Bids: Out of all the bidders who have submitted their bids online, work order will be issued to only that firm which has quoted the minimum price and full fills all the conditions of the bid.
- 9. Work Order: The successfull bidder will have to sign a Notarized biparite agreement with ULDB on a Non Judicial Stamp paper of Rs. 100.00 denomination and will also have to submitt a performance security equivalent to 6 percent of the total bid price calculated for the total cost of services for the prescribed period to be made available. The performance security shall be in the form of a bank guarantee/demand draft/pay order/fixed deposit receipt issued by a nationalized/scheduled/cooperative bank pledged in favour of ULDB and payable at Dehradun. This perfoarmance security will have to be invariably submitted within a period of 2-weeks from the date of approval of bid and must be valid for a period of 60 days after the completion of performance obligation. In case the successful bidder is unable to submitt the performace security within the prescribed time of 2-weeks then the bid will be automatically considered as null and void and the bid security submitted by the bidder will be forfeited in favour of ULDB.
- 10. The bill for the services provided shall be paid every month after due certification and recommendation of the officer concerned for the NDLM project.
- 11. The successful bidder will under no circumstances use the logo of the Uttarakhand Livestock Development Board or the Department of Animal Husbandry or the Government of Uttarakhand for advertisement while recruiting the services of data entry operators for his/her firm. In case the successful bidder is found to be doing so it will be considered as a breach of the conditions of the contract and the work order of the successful bidder will be cancelled and the perfornace security submitted will be forfieted in favour of ULDB.
- 12. The Chief Executive Officer, ULDB has the right to accept or reject any bid or cancel the bidding process without assgning any reason thereof.

### Terms & Condition of the Bid

- 1. The National Digital Livestock Mission (NDLM) scheme is being implemented in the districts of Dehradun, Haridwar, Udham Singh Nagar and Champawat through the 85 Veterinary Hospitals/Institutions of the Department of Animal Husbandry, Uttarakhand for the purpose of which 85 data entry operators are to be made aviable.
- 2. The educational and other essential qualifications of the data entry operators to be made availabel are as follows:
- 2.1 The data entry operator made aviable will works under the direct supervision of the Officer incharge of the Veterinary Hospital/Institution.
- 2.2 The minimum educational qualification of the data entry operator made available will be intermediate pass (10+2) and must be essentially profficent in both Hindi & English typing.
- 2.3 The minimum age limit of the data entry operator made available should be 18 years and the maximum age must not be beyond 35 years.
- 2.4 The data entry operator made available must essentially have profficiency in the use of Microsoft Office (MS Office which includes working on Excel worksheets, word documents, power point, etc.) and should be profficient in the use of email. He/she should also be essentially able to type in both Hindi and English language.
- 2.5 The data entry operator made available will invariably ensure data entry of all the documents, data and inputs made available to him/her by the Officer incharge. The service provider shall be completely responible for any error or wrongful data entry by the operator provided and any corrections thereof will have to made by the service provider at his/her own costs. In case the service provider fails to do so then in such condition ULDB will deduct the actual amount paid by it for the corrections in the data entry from the service provider's monthly bill.
- 2.6 The data entry operator made available will ensure entry of data from the documents provided for the said purpose and other works assigned to him/her invariably within the stipulated time for the work.
- 3. The bids of only those bidders submitted online on the government e-procurement portalhttps: //uktenders.gov.in will be considered for opening who have submitted the following documents offline to the office of the Office of the CEO, Uttarakhand Livestock Development Board (ULDB), Pashudhan Bhawan, First Floor, Mothrowala, Dehradun-248001 before the last date and time of submission either by registered post or courier or in person:
- a. Cost of the tender document
- b. Bid Security
- c. Notarized declaration (as indicated in Annexure- of the bidding document) on a non judicial stamp paper of Rs. 100.00 denomination.
- 4. In addition to submitting the above listed documents a, b & c offline a scanned pdf copy of the same will also have to be uploaded online along with copy of PAN card, Adhar card and all other required documents included in the tender on the E-procurement portal https://uktenders.gov.in
  - The rates quoted by the bidder will have to be entered in the Bill of Quantities (BOQ) and submitted online on the e-procurement portal and rates in any other format or offline will not be entertained.
- 5. The bidders must possess a valid labour registration certificate, EPF registration certificate and a ESI registration certificate. The bid of any bidder not in possession of the above documents will not be entertained and will be liable to be sumarily rejected.
- 6. The successfull bidder will have to provide services of the data entry operators within one week of the issue of work order by ULDB.
- 7. The successful bidder will have to sign a bipartite agreement with the ULDB on a non-Judicial stamp paer of Rs. 100.00 denomination within two weeks from the date of issue of acceptance of bid for which the stamp paper will have to purchased/provided by the successfull bidder.
- 8. The successful bidder will have to submit a performance security equivalent to 6 percent of the total work value and will have to be submitted within two weeks of the acceptance of bid in favour of ULDB.
- 9. The performance security shall be in the form of a bank guarantee/demand draft/pay order/fixed deposit receipt issued by a nationalized/scheduled/cooperative bank pledged in favour of ULDB and payable at Dehradun. This perfoarmance security will have to be invariably submitted within a period of 2-weeks from the date of approval of bid and must be valid for a period of 60 days after the completion of performance obligation. After the completion of the bidder's performance obligation this performance security will be released to the bidder on a written request.
- 10. Under no circumstances will the cost of the bid document be returned. In case the bids are not opened on the prescibed date and time then the bids will be opened in the presence of the bidder or his authorized representative by the procurement committee on the new date and time so determined.
- 11. In case the data entry made by the data entry provided by the successful bidder is not as per requirment then the data entry work will be got done from other available sources and the cost of the same will have to be borne by the successful bidder which will be deducted form the successful bidder's monthly bill for which the successful bidder will be entirely responsible.
- 12. In case the successful bidder fails to provide data entry operators against the work order then the data entry and related work the ULDB will arrange for data operators from other sources. The actual costs incurred thereof will be deducted from the successful bidders monthly bill for which the bidder will be entirely responsible.
- 13. The agreement will be valid for a period of 12 months and may be extended on the extension of the scheme and as need may be, by mutual agreement of both parties.
- 14. Income tax will be deducted at source (TDS) by ULDB on the bills produced at the time of payment of the same on the applicable rates of the income tax department at that point of time.
- 15. It will be mandatory and the resposibility of the successful bidder to follow all labour laws including EPF, ESI, Minimum Wages Act, and all other relevant laws related to the provision of these services.
- 16. It will be the complete responsibility of the successful bidder for any claims or issues arising out of the any disputes, injury or accident of any of the data ebntry operators thus provided and ULDB in no way will be held responsible for the same.
- 17. In case the successful bidder is unable to provide the said services due to any reason and wishes to withdraw from the contract then the successful bidder will have to provide ULDB with an advance notice 02 months prior to expected date of

withdrawl of services. In case the successfull bidder fails to do so and stops providing services without any notice then the performance security submitted at the time of agreement and award of contract will be forfieted in favour of ULDB.

- 18. If the data entry operators provided by the successful bidder (service provider) fails to provide his/her services to the satisfaction of the ULDB then the successfull bidder will have to provide the services of an alternative data entry operator mandatorily within 03 days.
- 19. The payment of bills will be done within 30 days of recipt of bills by the ULDB after deduction of applicable taxes every month.
- 20. Any or all bids submitted by bidders on their terms and conditions will be rejected and will not be considered for evealuation under any circumstances.
- 21. All payments to be made in this bid like the cost of bid, bid security and performance security will not be accepted in cash.
- 22. The successful bidder will have to submit his/her firms Income Tax details as and when if required on demand to ULDB.
- 23. The successful bidder will under no circumstances use the logo of the Uttarakhand Livestock Development Board or the Department of Animal Husbandry or the Government of Uttarakhand for advertisement while recruiting the services of data entry operators for his/her firm. In case the successful bidder is found to be doing so it will be considered as a breach of the conditions of the contract and the work order of the successful bidder will be cancelled and the perfornace security submitted will be forfieted in favour of ULDB
- 24. In case of any dispute the decision of the Chairman of ULDB will be final and acceptable to all parties concerned.
- 25. The definition of the acontract/agreement will be under the Laws of India and the settlements of all disputes will be subject to the jurisdiction of the Hon'ble Courts in Dehradun.
- 26. The Chief Executive Officer, ULDB reserves the right to accept or reject any bid or cancel the bidding process without assigning any reason thereof.
